Dear New Families,

Sierra Canyon uses an online database called **Magnus Health SMR** (Student Medical Record). This database offers many benefits, including less paperwork for parents each year, up-to-date information readily accessible to our nurses, and a single online location for families to complete school-related forms. As this is a web-based system, you will have continuous access to your child's health record. Additionally, you will have the option to take the digital health file with you when your child graduates.

Founded in 2006, Magnus Health is the leading provider of a web-based SMR program designed specifically for use in schools. Its primary focus is streamlining the collection and secure storage of health information in accordance with HIPAA, FERPA, and state regulations. Information and Deadlines Regarding 2026-2027 Forms

On May 1, 2026, you will have access to your child's Magnus Health SMR account to begin completing the health forms for the 2026-2027 school year. **After you log in to the Parent Portal, you can access Magnus via the button titled "Magnus Health" under the Resource tab.** We ask that you complete the health information required for each child attending Sierra Canyon School **no later than August 15, 2026**. Please reserve 15 to 20 minutes per child, depending on particular circumstances. Going forward, you will simply provide updates to the record as needed.

Please be aware that students will not be permitted on campus at the start of school until all health documents have been uploaded. We encourage you to schedule an appointment with your child's healthcare provider as soon as possible to ensure all required forms are submitted by August 15. This may include a general or sports physical exam, an up-to-date immunization record, and any medication forms that require a physician's signature. Families will continue to receive weekly email reminders if there are outstanding items in a student's Magnus account. If an item has been submitted but not yet approved by the Health Office, a reminder will be sent until it is approved. Please do not call the Health Office if an item is pending; they are diligently approving forms in the order they are received.

Students in Grades 9-12 participating in athletics are required to complete an annual physical exam to be eligible to compete. Sierra Canyon partners with EXER to provide free physical exams for one week in late May, and the Athletic Department will share more details in the coming weeks. Once completed, physicals can be uploaded to Magnus at any time. Additionally,

several read-only athletic forms require electronic signatures, so please review and complete them as needed.
